³ SCU students studying at a domestic visiting institution pay tuition to the institution they are attending. Students from a domestic visiting institution studying at SCU pay tuition to SCU at the standard rate.

⁴ Students in the Law School consortium (SCU, USF, Golden Gate University, UC Davis) take courses at their home institution and can take a class at a consortium institution. Students from consortium schools taking classes at SCU have tuition suppressed.

⁵ LLM rate is charged for LLM students participating in Study Abroad Courses and Externships

⁶ The SNU Program is 12 units. The Summer 2023 and 2024 rate is TBD.

⁷ If five or more students participate from the same law school, their students will receive a discount of 15% off the standard tuition rate. This is applicable to course tuition only and is not applicable to externships tuition.
