SVCN is currently seeking interns for Spring 2011 (January 31st-May 15th); interns are expected to devote at least 12-15 hours a week to the internship. We are looking for prospective interns with interest in the following areas:

- Public Policy and State, Local Budget Planning
- General Public Policy and Nonprofit Researcher in areas such as Juvenile Justice, Senior Nutrition, and Civic Engagement
- Key analyst on economic trends in Santa Clara County and the City of San Jose

Intern will gain valuable hands-on experience working on a variety of public policy issues. Some of these issues include: reviewing impacts on drastic cuts to community services at both the City of San Jose and Santa Clara County, assisting in rallies and advocacy activities to preserve services, attending key government committee hearings to track legislative actions, research potential ballot measures, and make reports to respective SVCN Boards and Committees. In the past, SVCN interns have overseen candidate forums, research ballot initiatives, and have written policy papers that have been adopted both locally and by statewide advocacy groups. SVCN is the leader in public policy advocacy for the nonprofit sector in our community with over 200 agencies within our membership base and excellent resource for future employment.

Duties:

- Support all aspects of the SVCN public policy portfolio, including research, analysis, and development of policy positions that would impact the nonprofit sector.
- Assist in researching information and data collection to support our work in the area of public policy, government contracting and/or other areas of interest for use in reports and publications.
- Interns will interface with a variety of policy makers and elected officials at both the state and local level through meetings, hearings, and forums etc.
- Intern will participate in advocacy, education as well as coalition building on legislative issues.
- Represent SVCN at community meetings as needed.
- Other duties/special projects as may be assigned.

Organization Background

SVCN is a collaborative organization that takes positions on issues that impact our sector with a goal that Everybody Wins! To achieve results, we develop extensive groundwork in data collection, understanding government budgets and developing the nonprofit perspective. We work in partnership with our nonprofit agencies that are primarily health and human services community-based agencies with an emphasis on Santa Clara County. We currently have 200 members. Our office is informal, fast-moving, and demands an ability to work independently and efficiently.

SVCN deals with an array of systems and their sub-categories such as: Santa Clara County in areas of influence including: Mental Health, Social Services, Drug and Alcohol, and Juvenile Justice, as well as with the City of San Jose and philanthropic foundations. SVCN interacts with the County Board of Supervisors, the Mayor of San Jose and City Council, and the local Assembly and Senate delegation on a regular basis.
