

Jesuit School of Theology of Santa Clara University Student Expense Budget for the 2010-2011 Academic Year

Following is an estimate of the cost of attendance for each student. This budget is used in calculating expenses for financial aid and loan applications, for determining the economic need of foreign students, and is provided to assist JST students in estimating their budgetary requirements for the academic year. As you will note, this budget is for the **nine-month academic year only**. As these costs are only estimates, individual budgets may vary considerably. Keep this document for your reference.

For the purposes of loan applications, allowable expenses include tuition, fees, room, board (food), books, transportation, medical/dental and personal expenses related to school attendance. Consumer debt payments, car payments, charitable gifts, legal fees, life insurance, etc., are not considered allowable expenses. Any questions about this student budget with regard to loan applications should be addressed the Financial Aid Office of the Graduate Theological Union.

Tuition The following tuition figures are for full-time study for the 2010-2011 school year. Please refer to the JST "Tuition and Fees" page for additional information.

Sabbatical and Special Students are charged on a per-unit basis: \$640/unit.
