COURSE DESCRIPTION: FAMILY, RELATIONSHIPS, AND MINISTRY

This course prepares ministers to partner intentionally with parents and families as primary agents of faith formation in the contemporary Catholic Church. Students develop pastoral leadership skills and practical strategies that strengthen family life, cultivate healthy relationships, and support faith across the lifespan.

Grounded in *Amoris Laetitia* and pastoral practice, the course invites students to engage the realities facing families today—including diverse family structures, cultural contexts, generational dynamics, gender and sexuality, and changing patterns of relationship. Emphasis is placed on the minister's role as an *accompanier*: walking with families, listening deeply, and fostering life-giving relationships that sustain discipleship within the parish and wider community.

LEARNING OBJECTIVES

This course addresses the following Goals and Objectives of the GPPM Program:

- **Goal 1: Theological Foundations:** Knowledge of the broad intellectual foundation for ministry in the areas of scripture, systematic and contextual theology, and spirituality; and incorporate theological reflection to enrich their ministerial practices across varying contexts.
- **Goal 2: Pastoral Proficiency:** Familiarity with ministerial practices in various manifestations of church life, expressed in concrete pastoral applications which include discernment, compassion, and ministries of accompaniment.

Course Work:

- 1. Informed and Engaged Class Participation (20 points):** Attendance is expected at all face-to-face and online classes. Thoughtful and reflective participation is expected, including sharing comments and questions throughout the course and via Camino, our online class platform. For each class session, you will be awarded up to 2 points: 1 point for attendance in class and 1 point for participating in the online discussion. To earn full credit for each class, participation in class and in the online discussion forum is required.
- 2. Written Work (30 points):** Written work will be evaluated on quality of content, organization, clarity of expression, grammatical correctness, and appropriate citations.
 - a. Reflection paper: Due by Friday, May 8, 2026. (4-5 pages; double-spaced, 12 pt. font; submit via Camino). The purpose of this paper is to articulate and integrate insights from your reading and our class discussion specifically around innovative ways to evangelize and engage parents and families in a more secular and unchurched world and developing deeper engagement with “cultural Catholics”. Prominent question for reflection: How can we engage parents and their families in formation and Mass? In what ways might we provide tools for families to implement faith activities at home? Further questions for your consideration will be posed in class sessions. Be sure to reference and quote assigned readings up to this point in the class in the reflection paper to show knowledge and understanding of the subject matter.

3. **Final Project and Class Presentation (50 points):** Each student will select a topic of particular interest or concern regarding families and parents in their existing ministry. In consultation with the instructor, the student will develop a specific project: for example, it might be a new process to support parents as the primary educators of the faith, or a redesign of an existing outreach efforts to non-traditional families, etc. There is a lot of room for creativity on this project. The key is that this project be something that you can implement in your ministry. I am not interested in a purely theoretical project, but one that is practical and realistic. On the day of our last class session, students will give a brief (15 minute) presentation on the project. A written report is required that documents the scope and development of the project (8-10 pages). PowerPoint presentations and other media tools are required and should be submitted along with the paper. Guidelines will be presented in class.

GRADING

- 20% attendance/informed & engaged class participation (20 points total);
- 30% reflection paper (30 points total);
- 50% final paper/project/presentation (50 points total)
