



## Counseling Psychology 2025-2026

### What is Practicum?

Practicum is a required course that is taken in conjunction with a graduate level counseling experience in the MFT/LPCC field. Practicum is intended to be the culminating experience in Counseling Psychology and taken the last year of your academic studies. Students are given the opportunity, under professional supervision, to begin to develop and apply therapeutic skills in a clinical context. The MFT and LPCC are 90 unit programs that require 9 total units and 3 consecutive quarters (3 units each) starting in the fall quarter.

## Practicum Instruction Core Content Areas

### 9 Quarter Units

- Students will have a *site practicum experience* to work directly with consumers and family members of consumers of mental health services so the student can better understand mental illness, treatment, and recovery. The practicum ranges from 18-24 hours per week at a site. For the 2025-2026 practicum year, students can begin collecting hours toward their practicum on or after Monday August 25, 2025 as they are considered officially enrolled in practicum.
- **MFT:** Supervised fieldwork experience with a minimum of 225 hours of face-to-face experience counseling individuals, families, or groups. Up to 75 hours may be gained performing client-centered advocacy. SCU-CPSY requires a total time at the site for the academic year to be at least 550 hours.
- **LPCC:** Supervised fieldwork experience with a minimum of 280 hours of face-to-face clinical experience counseling individuals, families, or groups. SCU-CPSY requires a total time at the site for the academic year to be at least 550 hours.
- Mental Health Recovery-Oriented Care and Methods of Service Delivery in Recovery-Oriented Practice Environments to include:
  - assessment, diagnosis and prognosis
  - justice, equity, diversity and inclusion
  - treatment planning
  - issues of development, adjustment, and maladjustment
  - health and wellness promotion
  - mental health documentation and professional writing
  - treatment of individuals, couple, family and children
  - counseling interventions
  - suicide assessment and intervention
  - application of theory and psychotherapeutic techniques
  - community resourcing
  - case management
  - disaster and trauma response
  - advocacy
  - system of care both private and public
  - collaborative treatment
  - telehealth service delivery model
  - students developing the personal qualities that are related to effective clinical practice including integrity, sensitivity, flexibility, insight, compassion and personal presence

The Practicum Spreadsheet is a collection of clinical sites that contain descriptions of clinical sites throughout the Bay Area. This information should describe how each site would like to be contacted (i.e. send a resume, call to make an appointment etc.) If the information is not clear please call the site for interviewing dates and details.

Interviewing for a practicum site is like looking for a job. You will interview with various sites and eventually choose one that presents itself as the best match. You will probably be contacting the sites and conducting interviews from Winter through Spring quarter. Once you have sent your resume and set-up an interviewing schedule, continue with the next steps.

## **Features of Quality Supervision at a Practicum Site**

Most of the sites will have some of the features listed below. Few sites will have them all. Consider this list for each site you are interviewing; it will be a helpful tool in your decision-making process.

- \*One hour individual, triadic (one supervisor and two supervisees) and two hours of group clinical supervision per week
- \*Orientation program for trainees before the work begins
- \*On-going training in topic's relevant to the client/therapist relationship
- \*Audio recording
- \*Video recording
- \*One-way mirror
- \*Role Play
- \*Clinical write up and presentation in individual and /or group supervision
- \*Co-therapy with licensed supervisor in individual, couple, family, and/ or group therapy
