NCO CAUTIONARY CONSIDERATIONS

- NCO being used as offensive weapon
- De minimis violations
- Requested restrictions are:
 - Unreasonable
 - Unenforceable
 - Overly-restrictive
 - Punitive
 - Retaliatory

NCO ENFORCEMENT

- Who implements?
 - Title IX
 - HR
 - Student Conduct
 - Law Enforcement/Public Safety
- Who enforces?
 - Law Enforcement/Public Safety
 - Issuing office or referral to another office
- Tips for enforcement
 - Collaboration and communication
 - Managing expectations



NCO VIOLATIONS

- What happens if a party violates the NCO?
- What are the reasonable consequences given the violation?
 - Warning
 - Probation
 - Tighten terms of NCO/lengthen term of NCO
 - Suspension
 - Expulsion
 - Employment action



K-12 CONSIDERATIONS

- NCOs can be challenging when students are in the same class(es)
 - May be necessary to inform teachers to ensure enforcement
- Crossing paths in hallways, cafeterias, restrooms, media center
 - Inadvertent contact
- K-12 NCOs more commonly include:
 - Walking/parking
 - Route limitations
 - Staggered times for certain activities or use of spaces
