# SCU REQUIRED FORM #3: INSURANCE VERIFICATION FOR STUDENT TRAVEL ABROAD

**INSTRUCTIONS:** This mandatory form must be completed by all SCU students participating in university-sponsored international travel. Students must verify all types of insurance coverage they will maintain during the travel dates of the SCU program abroad, both en route and abroad.

**SUMMARY:** All students are required to maintain insurance coverage during university-sponsored international travel. There are <u>six types of coverage</u> students may carry while abroad, see below. Students may be covered by multiple insurance policies while abroad and it is important for students to understand what coverage they have, or what coverage they may need to purchase to insure sufficient coverage.

#### OVERVIEW OF STUDENT INSURANCE POLICIES FOR TRAVEL ABROAD

#### 1. SCU On-Campus Policy

All Santa Clara students are required to maintain coverage equal to or greater than the <u>on-campus Student Health Insurance Plan policy (SHIP)</u>. Students are automatically enrolled into SHIP unless they are approved for a waiver through SCU <u>Cowell Center's</u> health insurance waiver process.

## 2. Personal/Family Policy

SCU requires all students to enroll in the SCU on-campus Student Health Insurance Plan (SHIP). Students who demonstrate that they have a policy that provides alternate coverage equal to or greater than the SHIP policy may waive this insurance.

- 3. Mandatory SCU Emergency Evacuation Insurance through CHUBB
  All Santa Clara University matriculated students are covered by the University's policy
  for emergency medical care and evacuation and repatriation of remains. Policy
  information can be found here. This policy does not provide sufficient coverage alone. It
  is not possible to waive this.
- 4. Mandatory SCU Study Abroad Insurance through GEO Blue for participants of the programs below (only). Coverage includes: Medical care up to \$250,000/year; Travel en route to/from the program site outside of the U.S.; Travel during the program dates in locations outside the main program site; Coverage for both U.S. citizens and non-U.S. citizens The GEO Blue policy can be found here. It is not possible to waive this.

Mandatory SCU Study Abroad Insurance through National Healthcare Coverage for participants on programs in the following countries (only): 1) Australia; 2) England; 3) Scotland; 4) Japan, 5) Sweden. This insurance provides student coverage for students enrolled at universities in these countries while inside the country. It does not provide coverage en route to the country, when traveling outside the country, or outside the dates of the academic program. It is not possible to waive this.
