

**SUMMARY ANNUAL REPORT FOR
SANTA CLARA UNIVERSITY GROUP BENEFIT PLAN**

This is a summary of the annual report of the Santa Clara University Group Benefit Plan (Employer Identification Number 94-1156617, Plan Number 501) for the plan year 01/01/2019 through 12/31/2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

President & Board of Trustees of Santa Clara College has committed itself to pay certain medical, dental and vision claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Blue Cross of California, Anthem Blue Cross Life and Health Insurance Company, Cigna Health and Life Insurance Company, Delta Dental of California, Kaiser Foundation Health Plan Inc., Life Insurance Company of North America, Concern EAP, Reliance Standard Life Insurance Company and California Physicians Service to pay certain life, accidental death and dismemberment, medical, dental, vision, long-term disability, business travel accident and employee assistance claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2019 were \$29,735,350.
