## ELSJ Milestone: Critical Reflection Assignment #3

## PART 1: CRITICAL WRITTEN REFLECTION

In Critical Reflection Assignment #3, you must reflect deeply on the experiences you had during your immersion experience (the personal interactions with individuals and groups in the community, the immersion group discussions, etc.) and then analyze how those experiences relate to the following ELSJ Learning Outcome.

Also, in your critical reflection, be sure to include an analysis of the previous week's assigned readings (Chapters 5 & 10), indicating how they're relevant to the themes of the reflection.

- How does this issue impact some groups more than others (i.e., privileging some and marginalizing others)?
- What are some of the underlying causes of this inequality (e.g., such as social, structural, economic, ideological, political, historical, cultural, etc.)?
- What, if anything, is being done to address this issue in the community you encountered? What more could be done?
- 2. Locate yourself in relation to the social justice issue you have identified, and consider your relative privilege or marginalization in comparison to other groups with respect to this injustice.

For the social injustice topic you selected in PART 1, please research and provide 3-4 scholarly citations (e.g., peer-reviewed journal article, book, white paper, monograph) that you can use to develop your ideas further in the final research paper assignment. For each citation, please write a paragraph that explains how the work might be relevant to your topic.
